Accommodation: The entrance hall leads into the impressive open plan living/dining room and very well appointed kitchen. There are two double bedrooms and this being the show flat it does have fitted wardrobes included although these are not standard spec', there is an ensuite shower room to compliment bedroom one as well as the main bathroom. Max measurements from plan: Living space 21'11" x 18'10" (6.68m x 5.74m), Bedroom one 14'3" x 11'8" (4.35m x 3.56m) Bedroom two 15' x 8'9" (4.58m x 2.68m).

Outside: This property has the benefit of its own lovely garden to the front with lawn and patio. There is then an attractive communal garden to the front as well as three visitors parking spaces. A ramp then leads down to the underground car park where this flat has an allocated parking space. EV charging provided at ground level.
