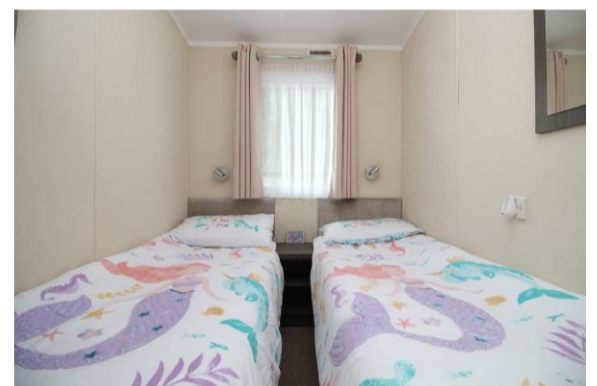
Outside: There is a general parking area opposite. The sun deck does indeed facing a nice sunny direction!
