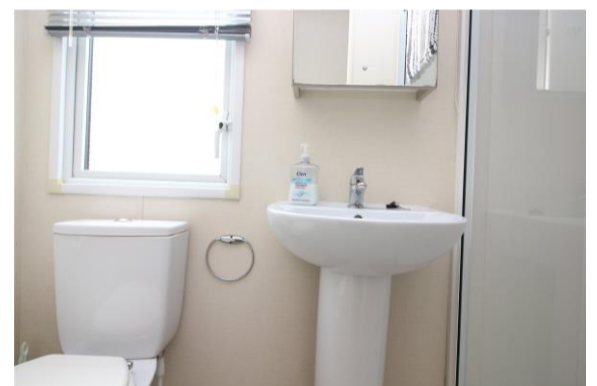
Outside: There is a parking bay, and a decked area to the front which sweeps around to the side as well.
