Accommodation: The entrance hall leads into the wonderful L-shaped living/dining room. There is then a very well appointed kitchen/breakfast room with various integrated appliances. The inner hall area then leads to the two double bedrooms, bedroom one has a lovely outlook over the rear garden and benefits from a modern ensuite shower room. Bedroom two has fitted wardrobes and adjoining this is a modern bathroom.

Outside: To the front is an area of garden and adjoining this the driveway gives off road parking, and leads to the garage 5.3m x 2.5m with power supplied. There is then the attractive rear garden which comprises lawned area. Also, the tank for the LP gas and adjoining the rear of this lovely home is a lean to garden room. Lovely woodland walk adjoining.

Location: - There is a pleasant little community on this site which enjoys a lovely location on the fringes of New Milton and the New Forest National Park. Sammy Miller Tea Room is opposite and Beechwood Stores is within walking distance, just off Stem Lane. The site has its own bus stop and we are told the bus runs weekdays into New Milton/the large Tesco and back.


