Accommodation: The front door opens to an entrance hall and then in turn a bright double aspect living room with feature fireplace. An archway leads to the dining room which has french doors to the garden and also opens to the kitchen and then in turn a separate utility room, which also has a back door. There is an inner hall accessing the two double bedrooms both with fitted wardrobes, bedroom one has an ensuite cloak/dressing room and there is a main shower room.

Outside: This lovely park home sits on an unusually good sized plot with gardens to all four sides, the wide driveway gives off road parking, accessed via gates. There is then an extended decked area which adjoins a lovely lawn with shrub borders, there is a shed and greenhouse. To the other side a further paved area.

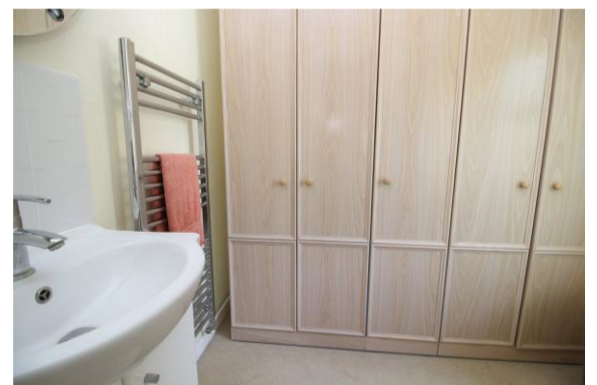
